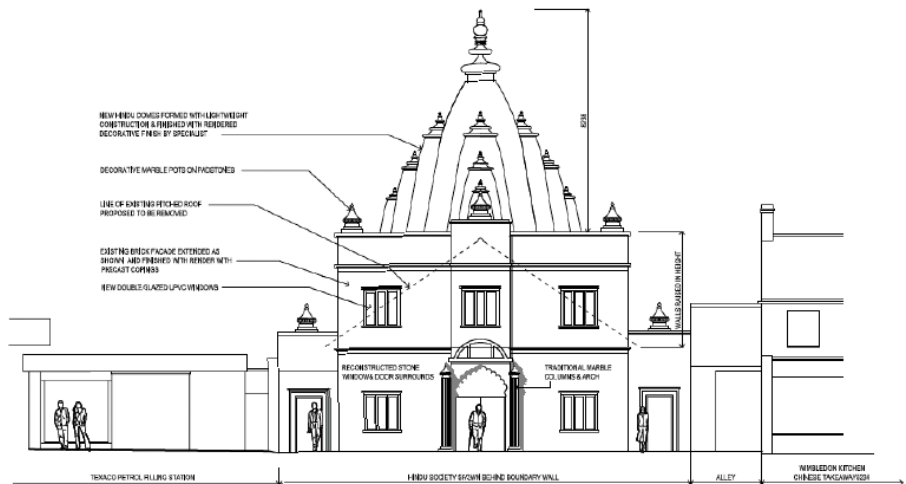
### MANDIR BUILDING

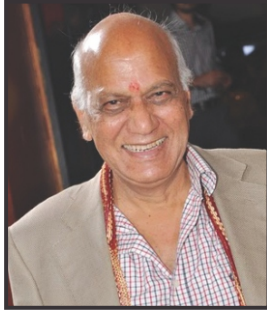
